## <u>ASSIGNMENT; TRANSFER – NON-CERTIFIED STAFF</u>

The Superintendent shall make non-certificated staff assignments in the manner best calculated, in his/her judgment, to enhance the educational program.

Non-certified (support) personnel are subject to assignment by the Superintendent. If such assignment includes transfer, the Superintendent shall recommend the transfer for approval by the Board of Education. Procedures for such transfers shall comply with provisions of current negotiated agreements and state and federal law. Disciplinary transfers are prohibited. Particular attention shall be paid to ensuring to the extent possible that there shall be equivalence of staff among the schools. Discrimination in assignment, transfer and promotion shall not be tolerated (see 2224, 4211 and 4211.1).
