Fiscal Responsibility

Modest Tax Levy Increases

> 10-year average of tax increases is 2.34%

Debt Free

District has no debt (final debt payment in 2018)

Cost Saving Measures

- Shared services
- Joint purchasing arrangements (Ed Data, ESCNJ, CCESC, HCESC)

Capital Reserve

- Funding facility improvements without additional cost to taxpayers
 - > Examples:
 - 2023-24 = All Purpose Room and classroom flooring replacement project at TBD
 - 2022-23 = All Purpose Room renovation at TBD
 - 2022-23 = HVAC upgrades in both schools (gyms, media centers, APR)
 - 2022-23 = Replacement of both playgrounds at TBD
 - 2022-23 = New playground at CDW

Shared Services

• With the Borough of Old Tappan:

- Shared purchasing arrangements (e.g., fuel and rock salt)
- Sharing of and assistance with athletic fields
- Ongoing and dynamic process

• With other Northern Valley School Districts:

- Regionalized curriculum center
- Regionalized staff development program
- Regionalized special education programs
- Regionalized transportation (special education, general education, and non-public)
- Shared technology costs (e.g., internet, email, and hosting)
- > Shared purchased professional services (e.g., physical therapy, behaviorist, etc.)

Budget Challenges

• Increasing Enrollment:

- > 3.4% increase in enrollment from October 2021 to October 2022 (per ASSA)
- New development in Old Tappan
 - Additional increases in student enrollment
 - Increased associated general education and special education costs


Increasing Special Education Costs:

- ➤ Increase in number of Out-of-District special education placements
- ➤ Increase in tuition costs for Out-of-District placements
- ➤ Additional transportation costs
- In-district programs (i.e., MD and ERI Programs)
- Additional required staffing and services (e.g., speech, behaviorist, OT, etc.)

Increasing Costs:

- ➤ 6.0% increase in Consumer Price Index in last 12 months (Feb 2021 to Feb 2022)
- > 25% increase is transportation costs
- > 10% increase in energy prices in last 12 months
- Costs outpacing the 2% tax levy cap

Enrollment History



Revenue Overview


- 2% Tax Levy Cap

Tax Levy - Calculation

• The 2023-24 Tax Levy is calculated as follows:

2022-23 Tax Levy Amount =	\$15,993,801
Add: 2% Tax Levy Increase =	\$319,876
Add: Enrollment Adjustment Waiver =	\$429,907
Add: Health Insurance Waiver =	\$177,578
2023-24 Tax Levy =	\$16,921,162

• Note: For 2023-24, the District had \$1,203,180 available in Banked Cap.

Tax Impact

- To support the State Standards as contained in the budget:
 - > Assessed value of Borough increased by \$31.5M.
 - Cost is an additional \$0.0361 per \$100 in assessed value, which represents an increase of 3.90%
 - The tax increase is an additional \$24.15 per month for the average assessed home valued at \$802,031.
 - ➤ Debt Service has been eliminated as District is debtfree.
 - The total General Fund tax levy = \$16,921,162

Senior Property Tax Freeze Information

Senior Tax Freeze (Property Tax Reimbursement) Program

- Program for eligible senior citizens or disabled persons
- Subject to income limits (\$99,735 = limit for 2022) and residency requirements
